Rules and Regulations

Bidders (a term that includes applicants and any partner on a platform) shall be bound by the terms, rules and regulations set out in this Agreement and any changes made in writing must be made in writing and signed by the authorized officer of the 1st Arabia Company for Organizing Conferences, Exhibitions and Business Tourism. After the 1st Arabia Company for Organizing Conferences, Exhibitions and Business Tourism, which has the amendments and additions to the rights reserved to the Exhibitor under this Agreement, and shall not result in increased obligations for sponsors, agents or employees.

No bidder is allowed to bid unless all agreed fees are paid before the offer.

Exhibitors are expected to comply with any regulations relating to the building in which the exhibition is located and all governmental rules and regulations.

The bidder may not assign his rights to any company or another person, nor shall any bidder assign or sub-lease the offered space allocated to him wholly or partially to another party.

The bidder has no right to occupy any space he wants, although his requirements will be taken into consideration when allocating his space.

The bidder should not block the exhibitors nearby and not work in an unacceptable manner by the other exhibitors. All lighting within the display platform should be arranged so as not to distract attention from adjacent display platforms. It is also prohibited to operate loudspeakers, radio or other audio devices in an unacceptable manner by the exhibition committee.

The Exhibitor does not allow the use of withdrawals, donations or other promotional procedures that require the gathering of members and guests in a specific place and time. The Exhibition Committee shall first approve all extraordinary promotional plans.

The exhibition committee alone, which limits hours and so on, controls the hours of attendance and allows access to ticket holders, badges or identification badges that cannot be waived for change.

Any exhibitor will not be allowed to remove his display platform from the exhibition grounds before the expiry of the exhibition. A representative of the exhibitor must be present at the exhibition throughout the show and during the installation and dismantling of the display platform.

Cancellation of participation:

Notice of cancellation of all or a portion of any exhibition space must be submitted in writing (via email or certified mail, return receipt requested) and is subject to exhibitors payment of cancellation fees as outlined below:

Returned and cancellation fees are based on the total exhibit space. 1st Arabia shall not be liable for interest on any amount refunded.

The Exhibition Committee, Sponsors, and the 1st Arabia Company for Organizing Conferences, Exhibitions and Business Travel shall not be responsible for any loss, theft or damage caused by fires or any injury of any nature to any person or material. Although we take precautions to prevent the loss, we do not guarantee that it will not happen. Under this agreement, we expressly disclaim responsibility for any injury or damage. We urge exhibitors to secure their platforms and equipment where they are fully responsible for any personal injury. The publisher of the catalog, the Exhibition Committee, the Sponsors, the 1st Arabia Conference, Exhibition and Business Travel Company, its agents and its employees shall not be responsible for any errors or omissions in the prepared version provided by the advertiser or the bidder.

The Contractor shall notify the application of the 1st Arabia Organization for Conferences, Exhibitions and Business Tourism on behalf of each Participant by a date not later than the date indicated on the application form.
